



# KEY LEGISLATIVE VOTES & ACTIONS



The following pages contain key NATCA votes to help NATCA members make informed decisions in some key House and Senate races in the 2016 election. As you know, it is always important to protect our friends in Congress and increase our margin of support.

**KEY VOTES:** Support for a key vote or action is indicated as Right (R). Opposition to a key vote or action is indicated as Wrong (W). Members of Congress who did not vote on the bill are shown as No Vote (NV) – this also includes Delegates. Where there are asterisks, the Member of Congress was not in office at the time of the vote.

**UNANIMOUS CONSENT (UC):** UC is an agreement by all Senators present. In the Senate, a UC is a way of quickly acting on issues without taking a recorded vote. Therefore, a “UC” means that a roll call vote was not taken, so you will not find this vote listed for senators.

**VOICE VOTE:** A voice vote is an agreement by all Members present. In the House, a voice vote is a way of quickly acting on issues without taking a recorded vote. Therefore, a voice vote means that a roll call vote was not taken, so you will not find this vote listed for House Members.

We have also included the AFL-CIO’s lifetime rating of Members of Congress as an additional source of information for our membership.

## HOUSE OF REPRESENTATIVES

**H.R. 5785:** To provide for an annuity supplement for full-time air traffic control instructors under contract at the FAA, passed the House by a vote of 399-4. H.R. 5785 will help address the hiring of former controllers to train new controllers. A companion bill, S. 3217, was introduced in the Senate and is awaiting further consideration.

**H.R. 5325:** Continuing Resolution (CR) for 2016, passed the House by a vote of 342-85. Stopgap spending bill that extended current funding levels from September 30, 2016, until December 9, 2016; avoided a government shutdown.

**H.R. 2029:** Omnibus for 2016, passed the House by a vote of 316-113. Stopgap spending bill that extended funding levels from December 18, 2015, until September 30, 2016; avoided a government shutdown.

**Rep. Hice Amendment to H.R. 2029:** This amendment to H.R. 2029, sponsored by Rep. Jody Hice (R-GA), which failed by a vote of 190-232, would have eliminated official time for federal employees serving at the Department of Veterans Affairs. If this amendment passed and official time was eliminated at the VA, it could create momentum to include other agencies, such as the FAA. A corresponding amendment was not offered in the Senate, so you will not find this vote listed for your Senators.

**H.R. 719:** Continuing Resolution (CR) for 2015, passed the House by a vote of 277-151. Stopgap spending bill that extended current levels from September 30, 2015, until December 11, 2015; avoided a government shutdown.

**H.R. 1765:** the Reducing Flight Delays Act, passed the House by a vote of 361-41. This bill put an end to the April 2013 FAA furloughs of air traffic controllers and other aviation safety professionals. The furloughs occurred as a result of the spending cuts mandated by sequestration.

**H.R. 636:** the Federal Aviation Administration Reauthorization Act of 2016, which extended the FAA until September 30, 2017; passed the House by a voice vote.

**H.R. 5292 Cosponsor:** the Air Traffic Controller Hiring Improvement Act of 2016, streamlined the hiring process for air traffic controllers and ensured a path for collegiate training initiative (CTI) graduate and military veterans. H.R. 5292 was included in H.R. 636, the FAA Reauthorization Act of 2016. Being a cosponsor of H.R. 5292 indicates support for the bill.

## **SENATE**

**H.R. 5325:** Continuing Resolution (CR) for 2016, passed the Senate by a vote of 72-26. Stopgap spending bill that extended current funding levels from September 30, 2016, until December 9, 2016; avoided a government shutdown.

**H.R. 2029:** Omnibus (for 2016), passed the Senate by a vote of 65-33. Stopgap spending bill that extended current funding levels from December 18, 2015, until September 30, 2016; avoided a government shutdown.

**H.R. 719:** Continuing Resolution (CR) for 2015, passed the Senate by a vote of 78-20. Stopgap spending bill that extended current levels from September 30, 2015, until December 11, 2015; avoided a government shutdown.

**H.R. 1765:** the Reducing Flight Delays Act, passed the Senate by Unanimous Consent. This bill put an end to the April 2013 FAA furloughs of air traffic controllers and other aviation safety professionals. The furloughs occurred as a result of the spending cuts mandated by sequestration.

**H.R. 636:** the Federal Aviation Administration Reauthorization Act of 2016, which extended the FAA until September 30, 2017, passed the Senate by a vote of 89-4. This bill includes H.R. 5292, the Air Traffic Controller Hiring Improvement Act, which streamlined the hiring process for air traffic controllers and ensured a path for collegiate training initiative (CTI) graduate and military veterans.
