Proposed Amendment for December 2006 by Ken M and Jose C:

(a) IN GENERAL.-The amendment made by section 1 shall apply to changes to the personnel management system of the Federal Aviation Administration proposed on or after April 1, 2006.

(b) CHANGES SUBMITTED TO CONGRESS.-Any proposed change to the personnel management system of the Federal Aviation Administration submitted to Congress on or after April 1, 2006, and before the date of enactment of this Act under section 40122(a)(2) of title 49, United States Code, shall not be effective after such date of enactment unless agreed to by the Administrator of the Federal Aviation Administration and the exclusive bargaining representatives referred to in section 40122(a)(1) of such title.

- Should we take a shot on the 109th or wait till the 110th Congress? Ken does not believe the 109th will be doing anything. They have no clue what to do so far. The Omnibus bill may be stripped out from the individual bills (10 total, the other 2 covered defense and homeland security).
- If they are going to do an Omnibus, it may be a good thing for NLC to get involved during the month of December.
- NLC needs the above language to cover the other multi bargaining units imposed work rules that were implemented in June 05.
- Above language sends impasse to FSIP after Congress.
- Pat discussed the Hasting amendment with the NLC: Try to Amend language to stop consolidations and in the event of consolidation, collocation or deconsolidation that NATCA has a seat at the table in determining how, what, when, where and why. Also want us to address inherently governmental language in FAA reauthorization.

Meeting with NEB 11/14/06 @ 1100:

- By the end of this week, NEB will have more information about what they are working on with the FAA.
- NLC will provide NEB with a proposal for their consideration. The issues on the table are, fix Title 49, inherently government functions, consolidation.
- NLC wants to see the amendment covering all the other bargaining units and go back to year 2005.
- Status quo ante is the goal for 109th and 110th to put pressure on the Agency.

• Database: All NATCA databases are in need of updating to be able to have current info on PAC members as well as retirees, trainees, etc... In the meantime we will have to go to facreps for the info needed on the Hill.

1) Strategies for 110th Congress - Option 1

- Status Quo Ante (over ATC and Multi Units, + PASS); use generic language instead of dates
- Back to the bargaining table
- Change Title 49: Process if we go to Impasse
- Consolidation and Re-Authorization : Get better language for FY07 (Similar to Hastings) and pass it through the Senate
- Inherently Governmental

<u>Strategies for 110th Congress - Option 2</u>

• Status Quo Ante

Recommendation to propose option 1 to ask for all what we absolutely need. If you take option 2, then we may get stuck with that one and with no hope to fix the other things we need, and we may end messing it up for 110^{th} Congress.
