## H.R. 1108/S. 762 Aviation Funding Stability Act of 2019

Following the 35-day government shutdown, House Transportation & Infrastructure (T&I) Committee Chairman Peter DeFazio (D-Ore.) introduced legislation that would authorize the FAA to draw from the Airport and Airway Trust Fund in the event of a government shutdown to ensure that all programs, projects, and activities can continue uninterrupted throughout the duration of a shutdown. NATCA worked closely with Chairman DeFazio, Aviation Subcommittee Chairman Rick Larsen (D-Wash.), and Congressman Bob Gibbs (R-Ohio) to garner support for this legislation. Following introduction, NATCAvists worked tirelessly to gain broad, bipartisan support for the bill. H.R. 1108 passed the T&I Committee on March 27, 2019 and, since then, it has gained over 300 cosponsors. A companion bill was later introduced in the Senate (S.762) by Senator Jerry Moran (R-KS). That legislation has gained 13 cosponsors.

## Senate Vote to Re-Open Government ("Schumer Plan" vs. "McConnell Plan")

On January 24, 2019, during the 35-day government shutdown, the Senate voted on two amendments to H.R. 268 relating to the government shutdown. These amendments were partisan votes between Republicans and Democrats and, as a result, the votes were mostly along party lines. The first amendment (#6, the "Schumer Plan") would have reopened the government by providing a two-week continuing resolution. It was rejected by a vote of 52-44 (60 required), with six Republicans joining all Democrats in voting yes. The second amendment (#5, the "McConnell Plan") would have reopened the government by providing full FY 2019 funding for the nine departments that were shut down. This amendment also included President Trump's immigration proposal. That proposal was rejected along party lines by a vote of 50-47 (60 required). Although we were disappointed by both failed votes, the process resulted in a group of bipartisan Senators rallying their colleagues to reach an agreement to end the shutdown. A day before the votes occurred, NATCA President Paul Rinaldi sent a letter to all U.S. Senators expressing strong support for *any and all* legislation that would end the partial government shutdown and reopen the FAA. Because these votes occurred in the Senate, you will not find these votes listed for your Representative.

## **House THUD Vote to Reopen the FAA (H.R. 267)**

On January 10, 2019, during the 35-day government shutdown, the House voted on a stand-alone FY 2019 Transportation, Housing, and Urban Development (“THUD”) appropriations bill (H.R. 267) that would have reopened the FAA. This was part of a strategy by the House Majority (Democrats) to bring individual appropriations bills to the House floor for consideration to open portions of the shuttered government in a piecemeal fashion. NATCA strongly supported this legislation and advocated for it on Capitol Hill in the days leading up to the vote. Ultimately, 12 Republicans joined all Democrats in passing the legislation by a vote of 244-180. However, Senate leadership did not bring any of the House-passed stand-alone bills to the floor for consideration, including H.R. 267. As such, you will not find this vote listed for your senators.

## **FAA Reauthorization Act of 2018**

The FAA Reauthorization bill is the authorizing measure that establishes, continues, and/or modifies FAA programs and activities. In April 2018, the House passed the FAA Reauthorization Act of 2018 (H.R. 4) by a vote of 393-13. However, the Senate’s path forward was not clear at that point. In September 2018, the House considered the legislation again as part of a larger bill (H.R. 302) that included hurricane relief funding. The House passed the bill by a vote of 398-23. The Senate followed suit and overwhelmingly passed the legislation by a vote of 93-6, and President Trump signed the package into law. The FAA is currently operating under this reauthorization bill through FY 2023.

## **H.R. 5292 Air Traffic Controller Hiring Improvement Act**

In 2016, Reps. Carlos Curbelo (R-Fla.) and Sean Patrick Maloney (D-N.Y.) introduced legislation in the House to streamline the hiring process for controllers and ensure a path for employment for graduates of the Collegiate Training Initiative and military veterans. The bipartisan bill garnered 260 cosponsors following the 2016 NiW, in which NATCAvists urged members of the House to co-sponsor the legislation. Thanks to our members’ activism and dedication, President Obama signed an FAA extension into law (P.L. 114-190) that included this critical legislation. A companion bill was not introduced in the Senate, so you will not find cosponsors listed for your Senators.

## **Hice Amendment**

In 2015, Rep. Jody Hice (R-Ga.) introduced an anti-official time amendment to the FY 2016 Military Construction-Veterans Affairs appropriations bill (H.R. 2029). This amendment would have eliminated official time for federal employee union representatives in the Department of Veterans Affairs. If enacted, it eventually could have led to the end of official time at other departments and agencies, such as the FAA. With NATCA’s help, this amendment was defeated in the House by a vote of 190-232, with 49 Republicans joining all Democrats to vote against the amendment.

## **Gingrey Amendment**

In 2014, Rep. Phil Gingrey (R-Ga.) offered an anti-official time amendment to the FY 2015 Transportation, Housing, and Urban Development appropriations bill (H.R. 4745). NATCA successfully led the fight to defeat this amendment, which failed by a vote of 167-254 in the House with 60 Republicans joining all Democrats to vote against the amendment.
