# **DUES PANEL TO DISCUSS STRUCTURE, FUTURE OF NATCA**

Southern Regional Vice President Victor Santore will moderate a panel on the important dues restructuring issue that delegates will consider today.

NATCA's dues are currently tied to the pay band minimums. Because pay band minimums are subject to negotiations, NATCA does not have sole control over the changing of pay band minimums, so we do not have control over our dues income. Furthermore, when facilities are downgraded, employees' pay is protected, but dues are reduced. Under the current contracts, bands increase at the same rate as the General Schedule increases, resulting in no movement some years and little in others. As the Dues Workgroup has made clear, the Union's income must be stabilized and completely isolated from the whims of the Agency and political winds. NATCA must remain financially prepared for the future.

Today's panel includes Executive Vice President Trish Gilbert, Southwest Regional Vice President and Dues Workgroup member Tim Smith, Region X Vice President and Dues Workgroup member Mike MacDonald, Finance Committee Chairman Ed

Szczuka, Dues Workgroup and National Validation Team member Eddie DeLisle, and Special Counsel to the President Eugene Freedman.

Based on the Dues Workgroup's projections, if no change is made to the dues structure, NATCA's income will drop dramatically; by 2016 NATCA will take in over \$2 million less than it did in 2012. This is partly due to retirements, but mostly due to facility downgrades. Furthermore, NATCA needs to protect its dues structure against economic downturns that reduce air traffic, thus also reducing facility pay levels.

As the panel today will explain, the proposed change that will be put before the delegates this week addresses all of the issues identified by the Dues Workgroup. It would mean NATCA's income would remain at, or slightly above, 2012 levels, delivering sustainability for the services and benefits provided to members.

### A LEADER, A BROTHER, A FRIEND: FORMER NATCA PRESIDENT BARRY KRASNER TO RETIRE



13th Biennial Convention, Honolulu, September 2010

If you've attended Convention before, you will notice a conspicuous absence this year on the dais. NATCA's Executive Director, former two-term president Barry Krasner, will retire soon. Few people in the history of NATCA have made the kind of selfless contribution to the rights and wellbeing of American aviation safety professionals that Barry has, and for this, we will all be forever grateful.

Barry started his career as an air traffic controller at New York TRACON (N90) in 1982, five years before NATCA was certified by the FLRA. By 1991, Barry had risen through the union ranks, and on January 31, 1991, he was elected NATCA's second president. He was reelected in 1994, the first NATCA president to serve two terms.

During his time in office, Barry dedicated himself tirelessly to fighting for his membership. He played a key role in the reclassification of air traffic facilities. This major effort helped pave the way for unprecedented pay increases for controllers when the Union's contract with the FAA took effect in September 1998.

Barry also worked hard to earn NATCA's affiliation with the AFL-CIO. By 1997, after Barry left the presidency, NATCA was finally recognized as a direct affiliate of the AFL-CIO, a major victory for a small union. He was also NATCA's chief negotiator for over 14 years, a hard-nosed union representative who was ceaselessly committed to protecting the collective bargaining rights of his membership.

In 2008, after retiring from the FAA, Barry joined the staff at the National Office as NATCA's Executive Director. His years of experience with contract negotiation, labor relations, and parliamentary procedure have served him well in that role. As Executive Director, Barry has been NATCA's tactical negotiator and a cornerstone to the future of our great Union.

"When I think about NATCA, I think about Barry," NATCA President Paul Rinaldi said. "We all owe him a debt of gratitude for his years of dedication and sacrifice to the union he loves so much. NATCA is better, our working environments are better, and I think the National Airspace System is better because of him. I am proud to call him my mentor and my friend, and most of all, my brother."



# **A Special Tribute**

New York TRACON (N90) FacRep Dean Iacopelli said he was honored to have been the FacRep when Barry Krasner retired from active FAA duty several years ago. On that occasion, the N90 membership gave Krasner a plaque honoring his time spent as an air traffic controller.

For all of Krasner's legendary accomplishments in helping to build, lead, and grow NATCA, Iacopelli said, "I have to believe the thing he's most proud of is when he was a controller vectoring airplanes in the LaGuardia Area." It was in that spirit of true brotherhood with the tight-knit N90 local that the **New York TRACON Barry Krasner Award** was created. It's presented at each convention to a member of the Union or the National Office staff.

Past recipients include former President John Carr, former National Office Executive Assistant Adell Humphreys, and former Labor Relations Director and contract negotiator Bob Taylor. The most recent recipient, honored at the 2012 Denver Convention, is Special Counsel to the President Eugene Freedman.

# **MSP** MINNEAPOLIS TOWER

"The atmosphere at MSP is nothing short of awesome," says FacRep Sam Tomlin. "We have a group of people here who are dedicated to not only the profession but NATCA."

The 38 NATCA members at the level 11 tower enjoy spending time together outside of work. Activities include summer boating excursions, fall bowling events, and ice fishing and curling in the winter.

Looking ahead, NATCA members at MSP are very excited that Vikings Stadium in Minneapolis has been selected to host the 2018 Super Bowl. The city previously hosted the event in 1992.

"The best part of being FacRep at MSP is the members themselves," Tomlin said. "It truly is an honor to serve the members and help with issues that arise."

# **M98** MINNEAPOLIS TRACON

Minneapolis TRACON (M98) is a level 11 facility with 60 NATCA members. The current facility was remodeled in 1997.

Major events in and around the Twin Cities keep M98 controllers busy. These include the Republican National Convention, the Major League Baseball All-Star game, and the upcoming 2018 Super Bowl.

Outside of work, the M98 local joins with Minneapolis Tower (MSP) and Minneapolis Center (ZMP) for annual solidarity and family events. M98 also holds monthly local meetings that bring together 20 to 25 members on average.

"We have a great membership that is always willing to work on and resolve issues. I never have a lack of volunteers here at the TRACON," says FacRep Roger Mathieu. "The best part of being the rep is the incredible support I get from the membership."

# FOUNDATIONS OF PROFESSIONALISM

Earlier this year, NATCA and the FAA created "Foundations of Professionalism," an umbrella term encompassing the collaborative programs that enhance and further the goal of the encouraging and maintaining the highest level of professionalism among the workforce.

### **Fully Charged**

NATCA, the FAA, and PASS are working together to promote fatigue education and awareness by providing the workforce with tools to selfeducate and mitigate fatigue hazards through a new joint campaign known as "Fully Charged."

Fully Charged was established in order to socialize the issue of fatigue in air traffic facilities throughout the nation, start a change in the culture of how the workforce thinks about and views fatigue, and remind aviation safety professionals to value alertness.

In a 24/7 operation, no one is immune to fatigue. The campaign focuses on the personal and shared responsibilities of fatigue mitigation, and is supported as a national priority by NATCA, FAA, and PASS leadership.

The campaign is the result of months of committed focus by the Fatigue Risk Management workgroup, which was created by the ATO Fatigue Safety Steering Committee in 2013. The group includes NATCA, FAA, and PASS representatives, and is supported by staff from the ATO Fatigue Risk Management team in Safety and Technical Training and Ph.D.-level fatigue scientists.

Through careful analysis of workplace data, the Fatigue Risk Management workgroup determined specific shift work associated with the highest fatigue hazards. The Fatigue Safety Steering Committee made recommendations to the FAA, NATCA, and PASS to manage and mitigate fatigue.

These recommendations, which have been accepted, include changes to operational policy and procedures. NATCA and the FAA are currently implementing changes, and PASS and the FAA are negotiating a memorandum of agreement that will take effect in January 2015. Additionally, the steering committee recommended that an educational campaign be developed for managers and employees.

NATCA officially rolled out Fully Charged at Communicating for Safety (CFS) earlier this year, earning praise from NATCA and aviation industry leaders who were in attendance, including NATCA President Paul Rinaldi, IFATCA CEO & President Patrik Peters, FAA Deputy Administrator Michael Whitaker, and ATO COO Teri Bristol.


The Fully Charged workgroup has recently launched "Fully Charged Shorts," oneminute videos of representatives from NATCA, FAA, and PASS discussing the importance of fatigue education and how they handle fatigue challenges at work. NATCA Professional Standards Co-Lead Jeff Richards, featured in one of the shorts, recalled driving home after working mids in the 1990s.

"I would drive home and not even remember the drive," he said. "And that's dangerous. Our people should understand that those dangers are there and how to recognize them."

Richards continued, "Fatigue is dangerous because the more fatigued you are the harder it is for you to identify that you are fatigued. It's very important to get the education piece out there, and we're going to do that with Fully Charged."

"I think Fully Charged makes us look at fatigue and say, 'You know what? There are ways we can actually mitigate those [fatigue hazards]," said MIA FacRep Bill Kisseadoo. "I think it's a great program. I'm glad that both sides got together and formed it, and are carrying it through together."

The organization is best known for three programs that meet that goal. The first is the well-known Homeownership Program in which volunteers build and rehab simple, quality homes in partnership with low-income families and the community. Twin Cities Habitat preserves homeownership by helping homeowners with the costs of maintaining their houses through their "A Brush of Kindness Program," and assists families who are facing foreclosure or who have fallen behind in their mortgage payments through their "Mortagage Forclosure Prevention Program."

A fourth program, Twin Cities' Veterans Initiative, offers support through Habitat programs and provides a way for veterans to connect with fellow service members and their communities. In November 2012, Twin Cities Habitat for Humanity became the first nonprofit in Minnesota to acquire Yellow Ribbon status, an accreditation by the VA to provide services to military families.

# **FINNEGANS: PROUD PARTNER OF NATCA CONVENTION**






