## Day 2: Delegates Wrap Timely Amendments, Resolutions

The second day of Convention business started off strong, as NATCA delegates returned to the convention hall ready to pass amendments to improve the Union. Credentials Committee Member Chris Boughn announced that 372 delegates and 139 alternates were in attendance after Paul Rinaldi called Convention to order.

Legislative Committee Chairman Steve Weidner was the first to take the stage yesterday morning to give the legislative report to the delegates. He began by introducing the National Legislative Committee members for each region and their hard work to make NATCA legislative activism so robust.

"I would just like to take this opportunity to thank them publically for all that they do for the Union," he said.

He continued, asking the delegates to not only continue their activism but also strive for increasing activism in their home facilities and regions. He said the increased activism helps NATCA make strong connections on Capitol Hill.

"NATCA could not care less what letter people have behind their name: D, R, or something else," he said. "We want to put NATCA behind their name. That's how we're successful on the Hill."

Rinaldi then picked up where the delegation left off yesterday, hearing the remaining proposed amendments.

#### NATCA Creates New Award, Honors Extraordinary Organizer

NATCA lost one of its founding fathers last year with the death of John Thornton. Today, we will honor Thornton's memory with a special presentation and the introduction of a new award named for him and inspired by his extraordinary contributions to the birth of our Union.

Thornton's influence was prominent as this "year of organizing" took shape. The NATCA Difference, at its core, is a proud belief in the collective power and strength of our great Union. The NATCA family puts the needs of the whole ahead of the individual.

Thornton embodied every great characteristic of a union man. He put his brothers and sisters' interests first. He also made the biggest sacrifice in 1981, as a member of PATCO.

"Not only did he go on strike to try and fix the bad working conditions that we all know about, he also served 10 days in jail with a handful of other strikers," NATCA Executive Vice President Trish Gilbert said. "As we know now, firing our PATCO brothers and sisters didn't fix the problems."

Those who were hired to fill the open controller positions, including many who have attended Convention this week, faced the same challenges and struggles. It was Thornton who then helped them by leading a new effort to unionize.

The new Thornton Award inscription reads, "In Recognition of Extraordinary Contributions That Have Significantly Changed the Course of NATCA's History."

It is fitting that the first award was presented to President Emeritus and NATCA Executive Director Barry Krasner, who spent his career at N90, was present at NATCA's founding convention in 1986, and later became the Union's first two-term President (1991-1997).

NATCA honored Krasner, and presented him this award, at his retirement celebration on Sept. 4, in Washington, D.C. He thanked the NATCA membership and staff, calling his efforts simply "standing on the shoulders of giants," a phrase he said originated with former President John Carr.

"For everybody out there who does everything you do, you are all giants, and I thank you for all the times that I got to look good at your expense," he said. "Thank you very, very much."

#### **INTERNATIONAL PANEL RECAP**

NATCA hosted a panel of international air traffic organization and union leaders yesterday to help NATCA's membership understand what different systems provide, and what funding processes they have in place.

"We are not in a position to say everything is fine," said moderator Trish Gilbert, NATCA's EVP. "Our top goal is to figure out how to maneuver through all the rhetoric and opportunists, and fund the NAS."

Canadian Air Traffic Controllers Association (CATCA) President Peter Duffey discussed the ATC transition in 1993, from federal government control to a non-government corporation not-for-profit. His advice for the NATCA membership was, if they decide to change the NAS funding, to "drive the bus, not ride it."

ATCOs Branch of Prospect Chair Paul Winstanley said NATCA needs to prepare for the worst if it decides to change the funding structure. He also said NATCA should "choose its bedfellows wisely." His organization is part for-profit, with airlines owning a portion and participating on the organization's board, which makes things difficult at times. Winstanley added that the best thing about UK's transition was moving away from pay restraints and pension protections.

Civil Air Australia President Daryl Hickey said the best thing about Australia's transition to a government enterprise was the advancement in technology. He added that the path of transitioning to a different funding structure isn't a quick one.

Duffey noted that the best thing about CATCA's transition to its new system structure was the 40 percent pay increase the workforce received right away, the equipment advances, as well as the contract terms achieved over the years. He said the worst part of the transition was 10 very tough years the workforce endured battling its managers. He said if he could do the transition over, he would want the union to be better prepared going into it.

Executive Vice President Trish Gilbert encouraged the delegates to pass the amendment. "It is time that we constitutionalize the Organizing Committee and make them a standing committee," she said.

Organizing Committee Chairman John Bratcher agreed.

"Without organizing, you can't have anything else," he said. "Without members, you don't have a family. We want to grow our NATCA family."

The delegation voted and the amendment was passed, making the Organizing Committee a standing committee.

A14-16 also sparked some controversy, as seniority typically does. The proposed amendment attempted to define how seniority would be accrued for time before NATCA was certified to represent each bargaining unit.

Great Lakes Regional Vice President Bryan Zilonis rose in opposition to the interpretation of the amendment's author and encouraged the delegation to vote against the amendment.

Miami Center FacRep Steve Wallace agreed with Zilonis. Referring to seniority, he said "we have made our voice heard many times about that issue". He then moved to end the debate and a vote was called, which resulted in the amendment failing.

The afternoon session generated the most debate, as R14-11 was brought before the delegation after having been postponed the prior day, proposing the elimination of the word "privatization."

Gilbert explained the rationalization behind striking the word privatization, saying the word is holding NATCA back from being a key voice in the discussion of the future of the NAS.

Atlanta TRACON member Jeff Wonser cautiously supported the resolution saying, "We need to be driving the bus, not sitting in the back."

He went on to acknowledge why privatization was originally added to the Constitution, but reiterated Gilbert's remarks that it is important for NATCA to be a key player in all discussions.

Oakland Center member Scott Conde also supported the resolution.

"This amendment is not this body saying we want to be privatized," he said. "When the battle changes, you have to change the plan. I strongly support the amendment."

Delegates opposing the resolution instead expressed interest in using a different word in place of privatization, however Robert's Rules of Order precluded an amendment to the NEB's proposal as outside the scope of the originally proposed change.

Southern Regional Vice President Victor Santore voiced his concern over the effects failure to pass the resolution would have on NATCA's contributions to future discussions.

"If you are worried about your pay and you are worried about our retirement, take a look at where the shots are coming from right now," he said. "Something needs to change. Let the best and brightest of your union protect your pay, protect your union, and protect your retirement."

The delegation ultimately passed the resolution.

The end of day two also brought an end to Convention business, with the exception of untimely amendments and resolutions submitted.

NATCA is proud to be a collaborative partner with the FAA and other aviation organizations. This era of collaboration has emerged from the hard work and relentless dedication of many NATCA members. Today, NATCA representatives from airspace, NextGen, safety, training, and professional standards will lead a panel discussion on these programs and the influence collaboration has had on their progress.

New York TRACON (N90) FacRep and Eastern ARVP Dean Iacopelli will moderate this important conversation.

"We plan on discussing the effect of NATCA involvement in Agency and aviation-related issues," Iacopelli explained. "We will be discussing the state of these programs prior to NATCA's involvement, how things have changed

since NATCA's involvement, and where we see things going in the future."

The benefits of collaboration can be seen throughout many programs. It is important to continue to work together to maintain and improve the safety and efficiency of the National Airspace System (NAS). Stakeholders' involvement in the decision-making process has proven to be vital in achieving success in these programs.

Joining Iacopelli on the panel discussion will be representatives from each of the topic areas: National NextGen Representative Mel Davis, National Training Representative Tom Adcock, National Greener Skies Lead Jeff Woods, and National Professional Standards Representative Garth Koleszar.

#### **DLH** DULUTH ATCT

With 19 NATCA members, Duluth ATCT (DLH) is a level five facility responsible for HIB, EVM, TWM, SUW, OLG, DYT, WI11, Y77, MZH, COQ, float plane bases, and two hospital helipads.

We have an excellent relationship within the membership, and with management," says FacRep Scott Kenner.

Every two years, DLH hosts an airshow with the Blue Angels as the headline act. The Cirrus Owners Association also holds a fly-in every July.

The close proximity to Lake Superior keeps the weather interesting for controllers at DLH. The lake creates a microclimate for the area, which can cause weather to fluctuate quickly. The temperature can vary from 80 degrees to 50 degrees within minutes!



#### **MIC MINNEAPOLIS CRYSTAL ATCT**

Minneapolis Crystal (MIC) is proud to be 100 percent NATCA! The level four tower is located a few miles northwest of downtown Minneapolis.

MIC hosts an annual Fathers Day fly-in that draws a large crowd. Plane and helicopter rides are available to the public thanks to Thunderbird Aviation and Minnesota Helicopters from the Anoka County Airport.

The tower is located near Target Field and the site of the new Vikings Stadium and primarily serves propeller-driven aircraft flown by private aircraft operators and recreational pilots.



#### **ZMP** MINNEAPOLIS CENTER

Minneapolis Center (ZMP) covers approximately 330,000 square miles of airspace in the Midwest. The level 11 facility, commissioned in 1962, employs 273 NATCA members.

ZMP also works aircraft from the University of North Dakota Aviation Department - the largest collegiate training fleet in the country.

Each year, the ZMP local puts on a "Best Brewer Oktoberfest" celebration, and also co-hosts a family bowling and arcade event with Minneapolis TRACON (M98).

"We continue to work on getting the newer CPCs involved in NATCA and to stress that it is their union," says FacRep Mike Thompson. "They need to be involved and make it what they want."

#### TIMMY AWARDS TO HONOR EXCEPTIONAL SERVICE TO NATCA

At each NATCA convention, union members and employees who have done an exceptional job representing NATCA values are honored with the Tim Haines Memorial Award of Honor and Distinction, otherwise known as the "Timmy Award." This prestigious award was originally named the "Natty Award," first presented by former President John Carr at the 2002 NATCA Cleveland Convention, then at the 2004 St. Louis and the 2006 Boston Conventions. The "Natty Award" was changed to the "Timmy Award" during the 2008 Miami Convention in honor of Tim Haines, who, with hard work and dogged determination, successfully implemented a reclassification project into NATCA's third contract, the Green Book.

Starting as a controller and then FacRep at Pittsburgh Tower (PIT), Tim Haines was elected Eastern RVP in 1991. Haines is remembered as a NATCA member who never backed down. Because of this staunch dedication, NATCA appointed him to a reclassification project that would revolutionize the way in which members of the Union are paid fairly. Many did not believe this project would be successful and thought the FAA would never agree to it. But Haines never faltered in his resolve to protect his profession and the well-being of each and every member of his Union.

After 18 months and 200 facility visits to observe air traffic operations, Haines and his team collected loads of data and presented their proposal at the 1994 Convention in Tampa, Fla. Shortly after, FAA managers came onboard and the project was put into effect in the 1998 Green Book.

Haines passed away in 2006, and this award recognizes members of the NATCA family for their relentless dedication and Haines-worthy commitment to NATCA.

#### CALL FOR NOMINATIONS: ARCHIE LEAGUE MEDAL OF SAFETY AWARDS

There are only a few more months to submit Archie League Award nominations for fellow NATCA members! All flight assists taking place this calendar year (January 1, 2014-December 31, 2014) are eligible for a nomination. It is best to nominate a member soon after the flight assist to ensure all required nomination materials are available. You may nominate a NATCA member from any facility, not just your own.

The awards banquet will take place during Communicating for Safety 2015 at the Rio in Las Vegas (March 2-4, 2015), and will mark the program's 11th year. Please review the helpful hints below before submitting your nomination. The nomination form and required materials have changed this year.

- An audio/video clip of the flight assist must accompany the nomination form.
   Oftentimes the audio/video is only kept on file for a couple months, so it is important to secure this material immediately following a flight assist.
- Transcripts, statements, media coverage, thank you notes from pilots, supervisor recognition, and Insider newsletter articles can also be submitted for consideration.
- Background information about the controller, including if he/she is a pilot, how many years he/she has been a controller, and any personal interaction with the pilot always complements a nomination.






