#### 2014 Federal Employee Viewpoint Survey

The Office of Personnel Management (OPM) has put out the 2014 Federal Employee Viewpoint Survey (FedView). In previous years the survey was offered on paper, but now is only available electronically. We have repeatedly raised the issue that many of our bargaining unit employees do not have or use FAA e-mail so distribution via e-mail will not be successful. Despite this obvious hurdle, we urge you to participate in the survey if you can.

FedView is a tool that measures employees' perceptions of whether, and to what extent, conditions characterizing successful organizations are present in their agencies. Survey results provide valuable insight into the challenges agency leaders face in ensuring the Federal Government has an effective civilian workforce and how well they are responding.

It is helpful to have a broad cross-section of the workforce participate in the survey in order to provide the best data. Our participation can only help paint the most accurate picture of how employees view working at the FAA.

# NATCA CONTINUES ITS SUPPORT OF ALPA in "SAVE OUR SKIES"

We at NATCA are proud to stand with our brothers and sisters at the Air Line Pilots Association, International (ALPA) in its campaign to Save Our Skies (S.O.S.) and deny Norwegian Air International's (NAI's) foreign air carrier permit application. Like ALPA, NATCA supports healthy competition in the U.S. aviation economy. But when companies like NAI try to undercut that competition by evading labor laws and collective bargaining requirements, they should not have the privilege of participating in the U.S. market.

NAI calls itself Norwegian, registers its airplanes in Ireland but does not fly there, hires its pilots in Singapore, and bases its flight crews in Thailand. NAI is doing this explicitly to avoid Norway's employment laws and is in direct violation of the U.S.-EU Open Skies agreement. Specifically, it is in violation of Article 17 bis, which prohibits the establishment of flags of convenience to evade labor protections and thereby derive a competitive advantage in the marketplace that is not in the public interest. We strongly encourage you to sign ALPA's petition that urges the Department of Transportation (DOT) to deny NAI's application. Should it be approved, tens of thousands of U.S. airline jobs for hard working Americans will be at risk and our nation's economy will be negatively impacted.

The #denyNAI petition already has 30,000 signatures but it may be missing one of the most important names - yours. We have signed it and urge you to as well. If you haven't already, sign the petition today and join the fight to protect the safest, most efficient, complex and diverse airspace in the world.



### NATCA'S 2014 Biennial Convention Chris Boughn 2014 MSP Convention Credentials Committee Chair

NATCA's 2014 Biennial Convention in Minneapolis, MN is rapidly approaching. Registration to attend the convention is now open at <u>natcaconvention.org</u>. All delegates, alternates, members and guests, should go to <u>natcaconvention.org</u> and register to attend the convention. Convention standing rules require that for admission to the convention hall all persons are required to wear a badge issued by the Credentials Committee. Registering online prior to convention will allow you to check-in and receive your convention credentials much quicker than if you wait until convention. Further, if you do not register in advance, you risk the possibility that we will not be able to accommodate your request to attend the various activities, dinners and the closing banquet during convention. Registration for the convention will remain open until August 31.

#### For FacReps only:

For Convention 2014, we have a new procedure for designating each NATCA locals delegates and alternate delegates. First all potential delegates and alternates must register to attend the convention at <u>natcaconvention.org</u>. When registering, you will not be asked if you are a delegate or alternate. Registration is open now and will remain open until August 31. Approximately 30-days prior to convention, each Facility Representative will be sent an e-mail with their facility's final delegate count and a link to an online form for the FacRep designate his/her facility delegates and alternates.

## A few reminders from the Article 8 of the NATCA National Constitution:

Section 2. Only duly elected delegates or their alternates may conduct the business of the Convention. Any member in good standing may attend the Convention and speak on any issue.

Section 3. Delegates and any alternates must be active members in good standing of the Association and of their respective Locals. No paid employee of any Local or of the Association, other than duly elected officials, shall be a delegate.

Section 4. Delegates and any alternates shall be elected by secret ballot in accordance with procedures set forth in each Local's constitution and bylaws. The Local is not required to conduct a mail ballot for convention delegates unless specifically required in their local constitution.

Section 5. Each Local shall be entitled to one delegate. Each Local shall be entitled to an additional delegate for every 50 members in good standing over and above 100 members. Each delegate shall be entitled to cast a number of votes equal to the number of active members in good standing in his or her Local thirty (30) days in advance of the opening of the Convention, divided by the number of delegates representing the Local properly registered and credentialed at the time of the vote.

Facility Reps should pay particular attention to section 4, "delegates and alternates shall be elected by secret ballot in accordance with procedures in each Local's constitution and bylaws." It is each individual Facility Reps responsibility to ensure that the procedures used to determine delegates and alternates has been accomplished in accordance with your local constitution. When you declare online who will be acting in these role(s), you will be asked to certify that this has been accomplished.
