





NATCA members and their Federal Aviation Administration management counterparts at Houston-area facilities have been preparing for months for their own Super Bowl challenge,



#### OSHA: Indoor Air Quality MOU Webinar

With the Slate Book, a new memorandum Of understanding (MOU) is in effect, requiring the FAA to adhere to the Indoor Air Quality Program Implementation Requirements (IAQ PIR).

It is important to immediately report any and all signs of water intrusion at your facility. Amongst other requirements, the MOU requires action within a given time frame after water intrusion occurs.
