

On this day in 1981: Nearly 13,000 Professional Air Traffic Controllers Organization (PATCO) members went on strike after months of failed negotiations with the federal government. Today marks the 34th anniversary of the strike.

More than 12,000 controllers - about 85 percent of the union's membership and 79 percent of the workforce - walked the picket line. Two days later, they were fired. In all, 11,350 controllers lost their jobs. About 875 returned to work before the firings. According to the Transportation Department, staffing dropped 74 percent: from 16,375 to about 4,200.

The men and women of PATCO, in their fight for a safer work environment, reliable equipment, adequate staffing levels and fair work and pay rules, took a stand in support of these goals and for the profession and system they held so dear. They made a tremendous sacrifice in defense of air traffic control and safety, and today especially, we honor that.

Today, we think of the PATCO members, both in our workforce now and those who are not. While the administration thought they could suppress the efforts of the nation's air traffic controllers, NATCA was born just six years later, while the same administration was still in office. We will never forget the sacrifices of those who came before us. Because of them, the pride, passion and determination to protect the safest, most efficient airspace system in the world are forever engrained in our DNA.

election winners.

Two new RVPs, Dean Iacopelli (Eastern Region) and Andrew LeBovidge (Southwest Region) ran unopposed and joined incumbent RVPs Mike Robicheau (New England Region), Kevin Peterson (Central Region), and Bryan Zilonis (Great Lakes Region) who were reelected by acclamation.

All 12 members of the NEB will begin serving their three-year terms on Sept. 1.

We are honored to have worked with the current NEB. We endeavored to work together as a team every day. We did that and are glad that we did as we worked through many challenges that would have been impossible had we not been on the same page. We will miss out-going RVPs Scot Morrison (Alaska Region), Phil Barbarello (Eastern Region), Jim Ullmann (Northwest Mountain Region), Victor Santore (Southern Region), and Tim Smith (Southwest Region) who did not seek re-election and will be retiring from the FAA soon.

The last six years have been transformational. The NEB has done a tremendous job of initiating the paradigm shift in our relationship with the FAA from combative to collaborative. Now, this new NEB gets to take up the work that has been done and continue to develop it to deliver results for our membership as they continue to run the world's safest and most efficient system. We have a lot of challenges in front of us and the Union will face some crucially important issues. It will take a strong NEB to embrace these next three years and help us increase NATCA's level of unity and solidarity. We are very happy for all of our incumbent and new RVPs, and look forward to working with them. It is a great honor and privilege to serve this wonderful Union, and we know everyone on this board shares that view and is grateful for this opportunity.



AFN Election: NATCA Works to Earn Votes from 1,300 Employees in New Combined Bargaining Unit NATCA members know how "The NATCA Difference" has changed their careers and professions for the better. The NATCA Difference is the Union's collective spirit; It's NATCA's solidarity; It's NATCA's long list of great successes in advocating and fighting for its members and their relentless passion for safety and professional standards. NATCA lifts up aviation safety professions to new heights.

Now, NATCA has an opportunity to grow the Union and show approximately 1,300 bargaining unit-eligible employees of the FAA's Office of Finance and Management (AFN) how NATCA can make a profound difference for them as well.

Led by the National Organizing Committee (NOC), a team of NATCAvists, Region X leadership, and National Office staff continue to prepare for an upcoming election that will determine which union will represent the AFN-wide bargaining unit.

This representation issue arose when the FAA realigned employees from across the FAA Staff Office and lines of business into the AFN organization, including those from the AIT, ARC, ABA, and ACQ units. The reorganization affected several existing NATCA bargaining units, along with units represented by six other unions. The Federal Labor Relations Authority (FLRA) then held a hearing in August 2014 to determine the appropriate bargaining unit. In March 2015, the FLRA issued a decision ruling that a single AFN unit is appropriate, and ordered an AFN-wide election to determine which union would represent all bargaining unit eligible AFN employees.

Many of these employees are located in service centers and district and regional offices, but others are located in air traffic control facilities.

The election will occur by mail ballot, from Aug. 20 through Sept. 23. The ballot count will occur in Washington, D.C., on Sept. 24.

Last week, NATCA held three meet-and-greet events for AFN employees at the FAA Regional Offices in New England (July 28), New York (July 29), and the FAA Headquarters building in Washington, D.C. (July 30), to kick off the campaign on a personal level. Each event was well attended by AFN employees who were very energetic and passionate, and all eager to vote.



We want to increase the reach and representation of NATCA. By representing as many lines of business as possible, it allows us to better represent our membership and grow our Union for the future. We want to retain our standing as the largest union in the FAA.

The efforts to reach these employees to ask for their vote are varied and comprehensive, including:

- Direct emails to introduce them to NATCA, explain why NATCA can best represent them, remind them of the dates of the election and the importance of voting, and explain how NATCA can help strengthen their voice as important FAA employees.
- Get out the vote efforts to encourage the employees to vote.
 One of the options on the ballot is "no union." Thus, NATCA's message to these employees is about both the value of

organizing their collective voice with union representation and

why NATCA is the union that can best represent them.

• Teleconferences for the employees to directly answer their

questions and address any issues.


