

#### Dear Sisters and Brothers,

The Senate Commerce Committee unveiled <u>its version</u> of the FAA reauthorization bill earlier this week. The Committee's proposed authorization only lasts until the end of fiscal year 2017, which means if this proposal is signed into law, Congress will work on a new bill early in the next session of Congress (the 115th). This will also be the case if Congress only passes extensions in this session (the 114th). An 18-month authorization allows lawmakers time to address some of the issues they have identified with the current authorization, while also buying them time to work through the more complicated areas of concern, such as drone privacy, passenger facility charges, and air traffic control reform.

The Commerce Committee plans to mark up the bill next Wednesday, March 16, with a possible vote on the Senate floor in April. We remain in close contact with Chairman John Thune (R-SD), Ranking Member Bill Nelson (D-FL), and their staffs about the details of the legislation which they have drafted to ensure our concerns are addressed and to seek inclusion of several provisions in

the manager's package of amendments (noncontroversial amendments) that will be considered during markup.

One of those issues is the hiring of air traffic controllers. In the Commerce Committee's proposed bill, we advocated for, and are glad to see, an increase in the maximum hiring age -- from 31 to 35 -- for air traffic controllers with previous military or civilian experience on the job. Unfortunately, there is also a provision that mandates the FAA establish guidelines for an in-person interview with all applicants for air traffic control positions before they could be hired to ensure English speaking proficiency. While we do not disagree with the logic, we believe a mandated in-person interview is not necessary and would have the unintended consequence of further delaying the hiring of air traffic controller candidates. Our understanding is that within the past two years, no employees enrolled at the FAA Academy have been required to take an English language proficiency exam. Further, the FAA website and the vacancy announcements already have a requirement that candidates "speak English clearly enough to be understood over radios, intercoms, and similar communications equipment." Our suggestion is that the language states that the Administrator ensures all employees enrolled in initial qualification training for air traffic control specialists at the FAA Academy meet the International Civil Aviation Organization's language proficiency requirements. We are also working with the Committee on its proposed pilot program to evaluate the feasibility of using remote towers, particularly in the Federal Contract Tower Program and for airports without any air traffic control tower, or to improve safety at airports with towers.

While both the House and Senate continue efforts to move their respective bills forward, House Transportation and Infrastructure Committee Chairman Bill Shuster (R-PA) and Ways and Means Committee Chairman Kevin Brady (R-TX) yesterday introduced an FAA authorization extension to fully fund the FAA and the federal aviation programs through July 15, 2016. H.R. 4721, the Airport and Airway Extension Act of 2016, is a clean extension of FAA programs and the Airport and Airway Trust Fund collection authority. H.R. 4721 avoids the lapse of the FAA's authority to collect aviation taxes. Without the extension, the FAA would have to engage in an emergency shutdown furlough and the Airport and Airway Trust Fund would lose approximately \$30 million per day.

Funding disruptions have needlessly created numerous problems for our workforce and the NAS, including staffing shortages and a slowdown in NextGen modernization projects. That is why our top priority continues to be securing funding certainty to create stability for continuous technology upgrades, long-term planning and hiring, and to ensure the safety of the NAS. A stable and predictable funding stream is also essential to adequately support air traffic control services, staffing, hiring and training, long-term modernization, preventative maintenance, and improvements to airport infrastructure. Uninterrupted funding is necessary to promote growth in the system and to allow us to continue to lead the world in aviation innovation.



# Air Traffic Control Specialist Hiring

The first of two hiring bids for air traffic controllers is out until June 21, for experienced controllers (52 weeks former FAA CPCs, Military controllers, DOD controllers and Federal Contract Tower controllers). Applicants will not need to take the biographical assessment, and depending on their experience may not need to go to the Academy. Click here to apply.

The FAA is planning a second bid in late summer or early fall. It will be a general public open bid. We are very concerned whether the FAA will meet their goal of a summer/fall bid. They have indicated to us that they want to validate a new ATSAT for use in that bid. Our concern is that validating a new ATSAT is requiring many controller hours out of the operation to validate it. With the workforce already short staffed, pulling the needed numbers to validate is problematic and may cause delays in the bid announcement. We will work with the FAA to help with the validation meanwhile advocating for a plan B as not to delay the bid.

Applicants in the open bid will need to pass the biographical assessment (as revised), the ATSAT (as revised, unless we can convince them to use the current one another time), and attend and pass the Academy. Academy graduates will get their facility placement upon graduation as is current practice.

### NATCA URGES PARTICIPATION IN FAA'S AT-SAT REPLACEMENT VALIDATION TESTING

Recently, many NATCA BUEs received notice that they had been randomly selected to participate in the FAA's AT-SAT replacement validation testing, which the Agency is conducting in conjunction with APT Metrics. NATCA urges those CPCs selected to participate in this very important endeavor. APT Metrics must test at least 1,600 CPCs to accurately validate the replacement test. Only by quickly validating a replacement to the AT-SAT can the FAA's CPC staffing crisis begin to be addressed. Unfortunately, the current number of CPCs who have either completed testing or signed up to test is far below the needed number to validate the test. NATCA encourages selected BUEs to work closely with their FacReps and ATMs to schedule a

testing date as soon as possible, and to discuss any questions or concerns with their FacReps or RVPs/ARVPs immediately.



MRA+30 and OPM

Recently, the Office of Personnel Management (OPM) resubmitted their <u>February 2006 guidance</u> to the FAA on Section 226 of Public Law 108-176, Vision 100, known as MRA+30. OPM advised the FAA that they still interpret section 226 as not applying to those individuals who occupy first or second level supervisory positions.

TMC time qualifies without any change. OPM has only distinguished between front line air traffic controllers, flight service controllers, FLMs, and second level managers. There is no special category for TMCs different than other front line controllers. We believe the FAA website's distinction for CPCs is not accurate, unless they are applying our definition included in Article 108, Section 2(F) of our CBA which includes TMCs and TMSs who are certified and are involved in the traffic flow management of aircraft under the definition of CPCs.

The deadline for registration is April 11, 2016. Participants will be selected based on the Congressional districts in which they reside. It is ideal to have as many Congressional districts represented as possible.

Again, if you wish to attend but are unsure if your leave will be approved, go ahead and register anyway. Attendance confirmation will be sent out on or about April 15, 2016. This should give you plenty of time to take advantage of advanced-purchase airfare. DO NOT purchase airline tickets until you have received confirmation from your regional NLC member that you will be attending AND approval from your local e-board.

Transportation to and from Washington D.C. will be at your local's expense. Transportation expenses will NOT be reimbursed from the NATCA in Washington budget. Therefore, please check with your Facrep first before registering. Any other incidental travel costs (i.e. cabs, tolls, etc) will also be at your local's expense.

Single rooms are on a first-come, first-served basis. If you are booked in a single room, you will be responsible for 1/2 of room charges per night (half the cost is approximately \$172 per night). If you do not indicate your choice of room (single or double) it will be assumed you want a roommate and one will be assigned to you. If you request a double room, but do not specify a roommate, your roommate will

be assigned by your regional NLC member. We always attempt to room members from the same region together (unless specifically requested otherwise), but if there is an odd number of attendees, you may be required to room with someone from another region.


