# Defending Public Safety Employees Retirement Act (H.R. 2146)

U.S. Representatives Dave Reichert (R-WA-8) and Bill Pascrell (D-NJ-9) introduced the <u>Defending Public Safety Employees Retirement Act</u> on April 30th and should come up next week, under a suspension, for a vote in the House.

We worked closely with both offices and their staff to include air traffic controllers when they re-introduced the bill this congress. As mentioned when introduced last congress, the bill proposes to amend the Internal Revenue Code to allow federal law enforcement officers, customs and border protection officers, and firefighters (and now air traffic controllers) to make penalty-free withdrawals from their taxexempt employee benefit and pension plans after they reach age 50.

We will definitely keep working with both staffs and the other organizations involved in this initiative. We will continue to post updates to this bill.

We thank Congressmen Reichert and Pascrell for their support. We look forward to working with them on this legislation as it moves forward.




## Air Traffic Controllers Hiring Act of 2015 (H.R. 1964)

U.S. Representatives Randy Hultgren (R-IL-14), Dan Lipinski (D-IL-03), Vicky Hartzler (R-MO-04), Cheri Bustos (D-IL-17), Matt Salmon (R-AZ-05), Tim Ryan (D-OH-13), Keith Rothfus (R-PA-12) and Elizabeth Esty (D-CT-05) introduced the <u>Air Traffic Controllers Hiring Act of</u> 2015 (H.R. 1964) on April 22nd.

NATCA has urged the FAA to select the most qualified candidates throughout the controller hiring process. With 20 percent of the controller workforce eligible to retire, maintaining adequate staffing is a top priority. Congressman Hultgren understands this concern. We have worked very closely with Congressman Hultgren, specifically on language to allow qualified candidates (experienced DoD, FCT, and FAA controllers) and CTI graduates with their schools' appropriate recommendation to bypass the biographical questionnaire that the FAA now uses. Additionally, work has been done on a section to fix a loophole in the law around the lack of an appeal process for veterans preference hiring decisions. While the bill is not exactly where we would like it, we support it because it would improve the hiring process. As written, the bill may unduly exclude potential qualified candidates that may be picked up under an open bid, such as remote pilots in our facilities. We would also like to add more language around veterans hiring as well.

We thank Congressman Hultgren for his commitment to aviation safety and hope that he receives many co-sponsors on the bill. We look forward to working with Congressman Hultgren as his legislation moves forward.

#### **Instructions to register for electronic voting:**

As in past national elections, NATCA members will have the option of voting electronically in the 2015 NATCA National Election. Because the candidates for NATCA President, Executive Vice President, Central Regional Vice President, Eastern Regional Vice President, Great Lakes Regional Vice President, New England Regional Vice President, and Southwest Regional Vice President were all unopposed, only members in the regions listed above will vote for a candidate for Regional Vice President from their region.

NATCA members are strongly encouraged to use electronic voting. To vote electronically, you must register with Global Election Services (GES) at https://www.esc-vote.com/natcareg.

The registration period for electronic voting will begin on May 16, 2015 and end at 5:00 pm EDT on July 27, 2015. The registration page is secure and you will only be able to register once. To complete registration, you will be asked to provide your name, address, region, and personal e-mail address. You will also be asked to answer a few security questions that will be used for verification purposes during the voting process. On June 30, 2015, each NATCA member registered to vote electronically will receive an e-mail from "natcahelp@electionservices.corp.com" at the personal e-mail address provided. This e-mail will contain a randomly selected login number and a link to the secure voting website. If you register to vote electronically, please adjust your e-mail spam filter as necessary to ensure that you receive e-mails from GES. And, if you change your personal e-mail address after

registering, please provide your updated e-mail address to GES via e-mail at "natcareg@electionservicescorp.com."

Members who register to vote electronically before ballots are issued on June 30, 2015 will not receive mail ballot packages at their home addresses, which will save NATCA a significant amount of money in printing and postage costs. If you do not register to vote electronically by June 30, 2015, a mail ballot package will be mailed to your home address. However, you will still be able to vote electronically. The mail ballot package will contain detailed instructions on how to vote electronically using a unique login number printed on the perforated section of the mail ballot.
