NATCA Remembers Retired ICT Member Mark "Finger" Goldstein

We were shocked, and deeply saddened by the death of our beloved colleague, friend, and NATCA brother Mark Goldstein in a tragic accident in Wichita. The accident occurred on October 30th when soon after take off he reported a problem with the left engine of the Beechcraft King Air he was flying. Our thoughts and deepest condolences are with all of our members and FAA employees at Wichita Tower and TRACON, where Mark served as a very skilled and highly professional air traffic controller. This is a terrible loss for them, and for everyone who knew Mark.

Mark was an air traffic controller for 33 years. Mark started as an air traffic controller in the U.S. Navy beginning in 1981. He retired last October to dedicate more of his time to flying and was instrument, commercial, and multi-engine rated. Mark began working as a contract pilot based out of ICT and also volunteered his time for youth organizations to spread his love of aviation.



Mark dedicated his career to aviation safety, which earned him two prestigious Archie League Medal of Safety Awards in 2004 and 2005.

The National Election Committee met in May 2014 to work on establishing the rules and dates of the 2015 NATCA National Election. The official notice of election/election rules will be mailed to each member's home address around the end of this year. Prior to that mailing, however, members should note the following important dates that the National Election Committee has established for next year's election:

March 31, 2015 - Nominations due for the offices of President, Executive Vice President, and the Regional Vice Presidents

May 1, 2015 - Nomination acceptances due

June 30, 2015 - Ballots distributed to the membership

July 24, 2015 - Deadline for duplicate ballot request

July 30, 2015 - Deadline for returned ballots

July 31, 2015 - Ballot count

September 1, 2015 - Elected officers take office

ATSAP Reaches Impressive New Milestone: 100,000 Reports

The Air Traffic Safety Action Program (ATSAP) has reached an impressive new milestone: 100,000 reports!

The total represents more than double the amount of reports filed just 28 months ago.

NATCA National Safety Committee (NSC) Chairman Steve Hansen said the milestone represents both the steady growth of the program and an increase in the overall awareness of ATSAP as a key component of the ATO's shift to a safety culture.

"When we first rolled out ATSAP in the fall of 2008, we did not expect any reports. But to our surprise, reports began flowing in immediately," Hansen said. "In addition to all the hard work the ATSAP team has done to ensure the program is a success, I believe this really shows that NATCA controllers care about the safety of the NAS and want to ensure their perspective is heard."

Added Mike Blake, the ATSAP representative on the NSC, "This milestone is a testament to the hard work our NATCA ERC members and analysts do every day to make this program successful."
