

Dear Brothers and Sisters,

As the communities clean up and repair damage in the aftermath of Hurricane Matthew, we count our blessings in that our membership suffered very little damage and all are safe. We still await news from our controller colleagues in Haiti and Freeport, Bahamas. All are reported safe in Nassau, Bahamas.

Before there were GoFundMe and other fundraising websites, in 1992, NATCA created a disaster relief fund following the devastation caused by Hurricane Andrew. After Hurricane Katrina in 2005, when many of our members were without essentials in its aftermath, NATCA used our disaster relief fund to purchase food and all kinds of supplies. Members from Florida and Texas took the items to our brothers and sisters who suffered the worst of the storm in Mississippi and Louisiana. Due to the generosity of our membership, the fund continued to grow after that horrific storm, and it allowed NATCA members to help those affected after Hurricanes Rita (2005) and Ike (2008). There has not been a call for donations to the fund since after Ike. Since then, we have provided supplies or assistance to controllers and aviation safety professionals after earthquakes in Haiti and Nepal, wildfires in California and Canada, floods in Baton Rouge, and Hurricane Sandy.

As Hurricane Matthew approached Florida, Georgia and the Carolinas, we made a plea for donations in order to ensure there were sufficient funds to purchase supplies our members might need in its wake. As always, our membership answered that call and generously donated approximately \$3,000 in a few days' time.

Thankfully, we will not need to use much from the fund, as the storm spared so many. Unfortunately, we know there will be another storm or disaster that

will affect those we need to support, and when it does we will be ready.

We would like to thank the leadership in the Southern Region and the many volunteers ready to assist, had it been necessary.

We would also like to acknowledge the dedication of the workforce before and after the storm. Many worked more than 24 hours straight with limited staffing so others could evacuate. Thank you also to the surrounding facilities that were not in the storm's path that worked to keep the system moving and safe.

The membership once again planned well, remained professional and committed themselves to the safety and security of the system as well as to each other!!

Professionalism Award Application Now Available!

Do you know someone who is an outstanding professional? Have you seen someone whose individual contribution and performance enhanced the standings of our profession? Then help us recognize them by nominating them for the second annual NATCA National Professionalism Awards, presented at Communicating For Safety (CFS) 2017! The deadline for submissions is Dec. 31, 2016. Submit a NATCA Professionalism Award Application today!

The National Professional Standards Committee (PSC) will invite the award winners to attend CFS to be recognized for their achievement and to receive their award. They will be entitled to travel and expense reimbursement, in accordance with the NATCA travel policy, similar to the reimbursement provided to the Archie League Medal of Safety Award winners.

The goal of NATCA's Professional Standards program is to maintain and promote professionalism across all of NATCA's bargaining units. We achieve that through a commitment to safety and the public's trust. We work to inspire, motivate and provide personal examples of our professionalism to others and to maintain the highest standard of excellence. We know our actions represent all our fellow professionals and we work to bring honor and respect to all that we do.

The NATCA National Professional Standards Workgroup has created a "NATCA Professionalism Award" as a means to recognize the actions of those who continually strive to achieve these goals.

Any NATCA member may nominate another member for the award, with no limit on the number of nominations received from a single Facility, Region or Service Area. Only members in good standing will be eligible to receive the award(s). A team of members is also eligible for the award and will be judged in the same manner as a single member.

The PSC must receive one (1) nomination via electronic submission for each event in order for the committee to consider it. Professionalism is seldom based on a single event but rather on a demonstration of consistent personal commitment to safety



and excellence, on professional contributions and on individual performance that enhances the standings of our profession.

Nominations should include a description of why the nominee deserves the award and all relevant information. The nominator should identify what the nominee did that enhanced the profession or promoted and maintained professionalism, and he or she needs to include statements or testimonials from other individuals supporting the nomination. The description can include transcripts or recordings of events and official documentation. Please submit as much information as possible on the nominee to assist the PSC in determining the award winners.

NATCA FLSA Lawsuit: Oct. 11, 2016, Update from the Office of General Counsel

NATCA continues to wait for the U.S. Court of Federal Claims to issue a decision on the damages portion of the Fair Labor Standards Act (FLSA) lawsuit that was remanded to the trial court by a federal appeals court in 2014. The issue that survived the Government's appeal of the trial court's initial decision in favor of the NATCA plaintiffs and was sent back to the trial court for further resolution was whether the FAA had to comply with the government regulations, and specifically the 24 hours cap on accumulated credit hours, if it maintained a credit hours program.

On Dec. 1, 2015, the Court of Federal Claims decided that issue in favor of the NATCA plaintiffs. The Court ruled that the FAA violated federal law when it allowed employees to accrue additional credit hours above the 24 hours cap and that affected plaintiffs were owed time-and-a-half overtime and an equal amount in liquidated damages. In pleadings filed earlier this year, the Government argued to the Court that it deserved an offset against the damages calculations that attorneys for the NATCA plaintiffs had previously submitted. NATCA counsel strongly disputed this assertion and the parties have had to submit several additional pleadings to the Court over the spring and summer on this final issue of damages calculations. The issue has now been fully briefed and the parties have been waiting since June for the Court's ruling. NATCA anticipates that a ruling could come at any time prior to the end of the calendar year.

NATCA will continue to update the NATCA plaintiffs as additional developments occur.
