We believe these systems may include, but are not necessarily limited to, eLMS, Employee Express. My Access, FAA email, PIV systems, and other systems that may require employees to be current in active directory.

NATCA has scheduled a full briefing with the FAA on this matter on Thursday, November 12. We will provide additional information as soon as possible following the briefing. In the meantime the FAA, albeit ever so slowly, is trying to identify and remedy the situation.



NATCA Participates in ATCA 60th Annual Conference

The Air Traffic Control Association's (ATCA) 60th Annual Conference and Exposition featured NATCA representatives and subject matter experts touching on numerous aspects of the NAS. ATCA also recognized several controllers and one of our NATCA employees at their awards luncheon.

Chicago Center (ZAU) won the Chairman's Citation of Merit



Award for employees' exceptional handling of aftermath and recovery from the 2014 fire outage at the facility.

Six NATCA controllers were awarded the Andy Pitas Memorial Award. This Medallion Award is presented to an individual or group who provided flight assistance that resulted in the safe recovery of an aircraft in distress through the application of exceptional air traffic service.

In November 2014, Hugh McFarland (Houston TRACON) received a call from a VFR-rated pilot who was stuck on top of solid IFR weather north of Houston. After flying toward Houston for almost two hours, the pilot in distress contacted air traffic control for help. McFarland, a certified multiengine instrument-rated pilot, answered his call



and talked the pilot through the weather. His professional, calm demeanor reassured the pilot in the air and helped him to land safely at Houston Executive

Airport.

Seattle Center (ZSE) controller Mark Haechler, who at the time of the incident was a trainee, noticed an aircraft on his scope that was unable to climb. The distressed pilot was in terrible weather conditions and experiencing heavy icing. Haechler declared an emergency for the pilot, and fellow ZSE controllers Matt Dippe and Alan Passero jumped on to help navigate him out of the bad weather. Their teamwork and quick thinking ensured a safe landing instead of a potential tragedy.

Orlando TRACON controller Sarina Gumbert was working the DRW position when a Cessna pilot departed directly into the path of a departing JetBlue aircraft. Gumbert immediately saw the errant heading and issued a corrective heading. She told the pilot to turn left immediately and began to call out traffic departing from the airport. As a result of Gumbert's expertise, the Cessna and JetBlue aircraft narrowly avoided one another during takeoff. William Beach, Albany-Dougherty, Ga., Federal Contract Tower (ABY), had worked over 30 years as an air traffic controller when he helped an aircraft pilot who was experiencing the symptoms of a heart

attack. Calling upon his many years of expertise, he was able to successfully guide the distressed pilot to a safe landing. Beach has distinguished himself and his profession



through his constant dedication to safety. His daily actions at ABY have earned the respect of everyone at the tower.

Elizabeth "Betsy" Beaumont, Fort Worth Center (ZFW), was honored with the ATCA Air Traffic Control Specialist of the Year Award. Betsy has maintained a high level of proficiency as a certified professional controller at ZFW, where shevolunteers


as the NATCA analyst for the central service area Air Traffic Safety Action Program (ATSAP) event review committee. In addition to her duties as a controller, Betsy has processed over 5,000 submitter reports this year-an average of 100 reports a week.



Sarah McCann, Senior Communications & Public Affairs Associate, NATCA National Office, is a member of the ATCA Publications Committee that was awarded the 2015 Presidential Citation of Merit Award. ATCA's President, Peter F. Dumont, recognized the group for each member's exemplary work in air traffic control over the past year, and for the overall enhancement of and contribution to air traffic control and the aviation community.

Art of the Airport Tower/National Air and Space Museum

Yesterday marked the opening of a new exhibition at the Smithsonian's National Air and Space Museum in Washington, D.C.: Art of the Airport Tower. This exhibition takes you on a photographic journey to airports in the United States and around the globe. Smithsonian photographer Carolyn Russo explores the varied forms and functions of air traffic control towers throughout aviation history and interprets them as monumental abstractions, symbols of cultural expression, and testimonies of technological change. These 50 images bring a heightened awareness to the simple beauty of the airport tower and a call for their preservation in the airport landscape.

The Smithsonian National Air and Space Museum describes the exhibition, "Often the first impression travelers have when they reach a new destination is the tower, and each tower tells a unique and important story about its airport, community, and culture. Visitors to the Stockholm-Arlanda Airport in Sweden are greeted by two lookout points perched like birds at the top of the control tower to evoke protective ravens from Nordic mythology. The crescent-shaped tower at the Abu Dhabi International Airport resembles the sail of a dhow boat to emphasize the area's proud maritime heritage. Historic towers, such as the Ford Island Tower that withstood the attack on Pearl Harbor, provide a glimpse into earlier aviation eras. Collectively these towers represent many countries and cultures. They play a pivotal role in the vast network of air traffic control technology that brings people of the world closer together. Russo's striking photographs and informative captions reveal the architectural, cultural, and technological significance of each of the featured towers. This one-of-a-kind view of airport towers will change the way you think about flight."

As the exclusive bargaining representative of air traffic controllers and other aviation safety professionals in the United States, NATCA is excited to be part of an exhibition that showcases some of the facilities in which these highly skilled men and women keep the skies of the world safe. Along with the professionals represented by <u>IFATCA -</u>

International Federation of Air Traffic Controllers' Associations, and by the International Transport Workers' Federation (ITF) Air Traffic Services Section, air traffic controllers in airport towers and radar facilities throughout the world guide approximately 100,000 commercial flights and tens of thousands of other types of aircraft each day, ensuring the safe transport of millions of passengers. Photographer Carolyn Russo captured the dynamic working environment within the towers featured in the exhibition as controllers inside worked as a team to keep planes moving through the sky. #AirportTower



Professional Standards Program Introduces the "NATCA Professionalism Award"

The NATCA National Professional Standards Committee (PSC) will present the award at NATCA's annual Communicating for Safety (CFS) conference.

The goal of our Professional Standards program is to maintain and promote professionalism across all of NATCA's bargaining units. We achieve that through a commitment to safety and through upholding the public's trust. We work to inspire, to motivate, to provide personal examples of our professionalism to others, and to maintain the highest standard of excellence. We know our actions represent all our fellow professionals, and we work to bring honor and respect to all that we do. The NATCA National Professional Standards Committee has created a "NATCA National Professionalism Award" as a means to recognize the actions of those who continually strive to achieve these goals.

At each annual Communicating for Safety (CFS) conference, the PSC will present one recipient from each FAA Service Area with a NATCA National Professionalism Award, a minimum of three recipients each year. The members of the PSC will determine the recipients no later than 60 days prior to the beginning of CFS and forward those names to the National Executive Board for approval. The recipients will be chosen based on their individual professional contributions and performance that enhanced the standings of their profession. Additionally, the PSC will consider their personal commitment to safety and excellence in the selection.

Each of the winners will be invited to attend CFS to be recognized for their achievement and to receive their award. They will be entitled to travel and expense reimbursement in accordance with the NATCA travel policy, similar to that provided to the Archie League Medal of Safety Award winners. The first annual NATCA Professionalism awards will be presented at the 2016 CFS conference in Las Vegas (March 21-23, 2016 at Bally's). Subsequent awards will be presented in the same fashion at each CFS.

Any NATCA member may nominate another member for the award, with no limit on the number of nominations received from a single facility, region, or service area. Nominations may also be drawn through the positive submission data provided via the Professional Standards Program data collection process.

Only members in good standing will be eligible to receive the award.

Examples of professionalism exhibited by a team of members are also eligible for the award and will be judged in the same manner as a single member.

Any example of professionalism exhibited since the inception of the Professional Standards program will be eligible for this first annual award. For subsequent awards, any example of professionalism that occurs after January 1 of the full calendar year prior to the CFS conference in which the awards are given is eligible.

One nomination form or electronic submission for each event must be received by the PSC to be eligible for consideration and judging. Copies of the nomination form are available <u>here</u>.

Along with the nomination form, applicants should submit a description of the event and, if available, the

audio/video tape of the event. The description should include all relevant information on the event, including the date and an account of the events. These descriptions should provide the selection committee with the details of the professionalism that enhanced the profession.

Other helpful documentation would include transcripts of the audiotape, official FAA forms documenting the event, statements from co-workers, and any other relevant data. Please submit as much information on the event as possible to assist the PSC in determining award winners.

On October 26, Paul spoke at an event to commemorate the completion of phase one of the remote tower system demonstration at Leesburg, Va., Executive Airport. The remote tower system demonstration is being conducted in two phases; it started in August 2015, and will carry through mid-2016. Saab is leading the development and hopes to achieve FAA

approval and certification for possible use of the system in the National Airspace System. Since Aug. 3, NATCA has provided a pair of controllers each week-one monitoring planes on the ground and one for those in the air - to be a part of the data collection activities at Leesburg with Saab's system. Controllers are monitoring flights as a test to gather information about the system, including how the aircraft in the remote tower system are visually identified, what effects weather and nighttime operations have on the operations, and other pertinent data.

On the same day Trish traveled to Chicago to brief the GL region facreps at their meeting. Later that week the entire NEB, NATCA Safety chairman and National training rep. also arrived in Chicago for a two-day collaboration meeting with us, the ATC COO, Deputy COO, VPs from Safety/Technical Training and Operations, Directors of Operations, and others. The meeting focused on training, staffing, negotiations (BWS/Leave), ERR processes and release policies. After lots of work the group committed to work harder to resolve the many challenges facing us.

The following week, the NEB met in D.C. the entire week. The NEB jointly met with the National Finance Committee (NFC) to scrub and vote on the 2016 budget. Additionally the NEB held our annual joint meetings with NATCA Membership Investments (NMI) and NATCA Charitable Foundation (NCF)

While in DC the NEB and the Alternate Regional Vice Presidents participated in media training. The training was hosted by NATCA's Communications Department at The National Press Club in Washington, D.C. The group learned about managing the media, how to control an interview and they practiced on-camera interviews.
