### New T-Shirt Celebrates 100-year Anniversary of Voting Rights for Women

Aug. 18 was the 100-year anniversary of the 19th Amendment to the U.S. Constitution that gave American women the right to vote. The amendment went into effect on Aug. 26, now celebrated each year as Women's Equality Day.

NATCA and the NATCA Charitable Foundation have created a special edition T-shirt to mark this centennial anniversary. The shirt graphic features yellow roses. 100 years ago, supporters of the 19th Amendment wore yellow roses during their campaign to achieve voting rights for women. A portion of the sales of each shirt will benefit the League of Women Voters (LWV).





The LWV was founded in 1920 to support the new women suffrage rights and help women take a larger role in public affairs after they won the right to vote. The LWV is officially nonpartisan and neither supports, nor opposes candidates or parties. Today, the LWV operates at the local, state, and national level, with over 1,000 local and 50 state leagues.

### Runway Safety Rep Leads Webinar for ICAO

Runway Safety: A Key to Re-building Confidence post-COVID 19



NATCA Runway Safety/Runway Status Lights Representative Bridget Singratanakul (Gee) helped lead an International Civil Aviation Organization (ICAO) webinar this month featuring presenters from across the global aviation community, including ICAO, the International Air Transport Association (IATA), the Airports Council International

(ACI), the Civil Air Navigation Services Organization (CANSO), the International Federation of Air Traffic Controllers' Associations (IFATCA), the International Federation of Air Line Pilots' Associations (IFALPA), and the European Union Aviation Safety Agency (EASA).

The webinar, entitled "Runway Safety: A Key to Re-building Confidence Post-COVID-19," discussed the challenges facing aviation as the world begins to recover from the current crisis.


ICAO wrote about the webinar, "Runway safety has long been considered as a global safety priority by ICAO. There is also an important association between the safety of runway operations and confidence. As demand returns, aviation's focus upon the safety of operations on progressively busy or recently recommissioned runways should be renewed."

Representatives joining Singratanakul (Gee) during the webinar were from countries that included: Ghana, India, Italy, Pakistan, Brazil, Yemen, Philippines, Australia, Paraguay, Guyana, Bolivia, Bangladesh, Israel, and Colombia.

**CNBC: Flight attendants turn to dog walking, contact tracing for extra income as they brace for job cuts** - The coronavirus pandemic has been so devastating to the airline industry that even flight attendants with decades of experience have been told that their jobs are at risk. <u>Read more</u>

**FORBES:** Airline labor unions, with Republican backing, are poised for historic win of billions in additional payroll aid - Assuming that Congress can come to terms on another major economic stimulus bill, the airline industry, led by its labor unions, has apparently garnered sufficient backing to extend payroll support until March 31, 2021.

That became evident Aug. 5, when 16 Republican senators said in a letter that they backed providing \$25 billion in additional federal aid for the industry as a response to the coronavirus crisis, which has seen U.S. air traffic fall by about 75%. The aid package already had backing from most Democratic senators. Read more

SIMPLE FLYING: United Airlines looks to limit furloughed flight attendants -United Airlines is seeking the limit the number of flight attendants it may have to furlough. Furloughs could begin on October 1st, unless the United States extends aid being given to American carriers, as a result of the current decline in passenger traffic.

Passenger traffic within the United States, and indeed around the world, has been slowly increasing since the darkest days in April. However, a full recovery of passenger numbers is currently expected by IATA to take until 2024. So far, many airline employees have remained active thanks to payroll assistance from the United States government.

#### Families First Coronavirus Response Act (FFCRA) MOU

On May 8, NATCA and the Federal Aviation Administration (FAA) signed a memorandum of understanding (MOU) regarding Human Resource Policy Manual (HRPM) Policy Bulletin 115, Paid Leave under the Families First Coronavirus Response Act (FFCRA). Policy Bulletin 115 and the MOU specifically address the FAA's implementation of FFCRA, which was signed into law on March 18. FFCRA provides expanded paid leave options for NATCA bargaining unit employees (BUEs) who have been affected by COVID-19. FFCRA provides two forms of paid leave: Emergency Paid Sick Leave and Expanded Leave under the Family and Medical Leave Act (FMLA), which can be utilized for the employee's own health needs or to care for family members.
