

## House T&I Committee Passes Shutdown Insurance Bill

On Oct. 27, the House Committee on Transportation & Infrastructure (T&I) passed H.R. 4042, the Aviation Funding Stability Act of 2021. NATCA strongly supports this important legislation which would protect NATCA's members and ensure that the



FAA could continue to meet its mission by maintaining the safety and efficiency of the National Airspace System during a lapse in appropriations for up to 30 days. T&I Chairman Peter DeFazio, D-Ore, Aviation Subcommittee Chairman Rick Larsen, D-Wash., and T&I committee members Brian Fitzpatrick, R-Pa., and Bob Gibbs, R-Ohio, provided tremendous leadership in shepherding this critical legislation through the committee. For many years, NATCA has advocated for a stable, predictable funding stream. This legislation would provide a temporary shield against destructive government shutdowns and protection for ongoing programs and projects that have to waste weeks preparing for potential shutdowns even when they are avoided at the last minute.

## Convention Update: Supplement Containing Additional Amendments Has Been Printed, Mailed

There were additional proposed amendments and resolutions for the 18th Biennial Convention (Dec. 9-10, Houston) that were submitted in the time after the original amendments and resolutions book was printed (in advance of a then-Aug. 10-12 convention) and before the 120-days prior to a December convention deadline early last August. # Plane & Pilot Magazine Story Details ZSE Members' Flight Assist Which Earned Them 2020 Archie League Award

NATCA's 2020 Northwest Mountain Region Archie League Medal of Safety Award winners are featured in the latest issue of Plane & Pilot magazine. The



story, written by Bradley Sunshine, details how Seattle Center (ZSE) members Josh Fuller, Byron Andrews, Brian Hach, Ryan Jimenez, and Michael Sellman worked together for two hours to save Idaho Cessna 182 Skylane pilot Tim Bendickson's life in a riveting flight assist that took place on the Saturday afternoon before Thanksgiving in 2019. Writes Sunshine: "A controller's voice truly controls traffic. Instructions delivered in measured cadence denote confidence. Pilots need to trust ATC clearances. Fuller and his colleagues innately understood that radar blips moved quickly; there was no 'pause' button in this game. Sometimes directives could not be repeated. The air traffic realm was measured in seconds versus minutes. ... The frightened voice transmitting from the clouds signified time was short—an inverted hourglass with sand rushing to the bottom. 'I'm at 6,000,' he radioed. 'I'm at 7,000 feet! I just about hit another mountain! I don't know where I'm at!'" Read the full story here.

## 20 Years Later, NATCA Remembers Meaningful Gesture from Pa. Students After 9/11

This month marks the 20th anniversary of a special interaction that NATCA leadership and staff had with a group of seventh and eighth graders from Hazleton, Pa., located just south of Wilkes-Barre. A few weeks after the horrific attacks on Sept. 11, 2001, then NATCA President John Carr and Executive Vice President Ruth Stilwell arrived at the National Office to find a stack of cards and letters from the West Hazleton Elementary/Middle School students thanking air
