

# NATCA Thanks Steve Dickson for Leadership, Collaboration During Challenging Period



FAA Administrator Steve Dickson announced on Wednesday his resignation effective March 31, 2022. President Rich Santa issued the following statement:

"On behalf of NATCA's National Executive Board and the more than 19,000 dedicated aviation safety professionals we represent in 15 FAA bargaining units, I thank Administrator Dickson for his strong leadership and for strengthening the successful collaborative relationship we have built with the Agency.

"We are proud of our work with

Administrator Dickson during a two-year period of unprecedented challenges posed by the COVID-19 pandemic. NATCA and the FAA swiftly worked to make decisions and create new procedures to protect the aviation safety professionals we represent, so they could ensure the continuation of the safe and efficient operation of the National Airspace System.

"From the earliest opportunity, we pressed for FAA employees to be included with other essential workers receiving priority for personal protective equipment (PPE), and we helped the FAA distribute it across the country. Since March 2020, we have consistently negotiated to ensure that the use of masks at FAA facilities was in accordance with the Centers for Disease Control and Prevention's (CDC) guidance as we collaborated with the Agency to mitigate member exposure to the virus. We have valued the leadership of Administrator Dickson throughout these efforts.

"NATCA members are also proud of the work we have done during this difficult time. Our members, and all of the FAA under Administrator Dickson's leadership, have been responsible for the safe and efficient delivery of PPE throughout the pandemic and have helped deliver hundreds of millions of vaccine doses across the country and internationally."

# Safety and Technology Update: Runway Safety



Every day in the National Airspace System, there is approximately one wrong surface alignment or landing, according to Article 114 Representative for Runway Safety Bridget Singratanakul (Dallas-Fort Worth ATCT, DFW). The Surface Safety Group (SSG) met earlier this month to discuss that and other issues. The group's purpose is to analyze surface safety risk to include runway incursions, surface collisions,

runway excursions, and wrong surface events. The group also has three subgroups that work on data analysis, technology initiatives/mitigations, and outreach. During the meeting, Singratanakul said they received updates from those respective subgroups as well as discussing memory aids, runway incursion mitigation (RIM), runway end identification (REIL) evaluation study, and approach runway verification (ARV) potential capability. 
