These forms include the LM-4, LM-3 and IRS 990-N (e-Postcard). The course is designed to benefit incoming FacReps and

treasurers, and it serves as a refresher for more seasoned E-board members. This one-hour course is important because it gives NATCA locals the tools needed to accomplish their responsibilities and be in compliance with SRD-8 of the NATCA National Constitution.
