

ITC Meets at National Office, Advancing Support for NATCA Members Nationwide

The Information Technology Committee (ITC) met on April 19-20 — the group's first in-person meeting since the pandemic began. The committee focused on learning about new tools and initiatives related to NATCA technology needs, as well as brainstorming ways it can streamline processes for sharing knowledge and tools to benefit all NATCA members.

Over the last two years, the ITC's workload and size has grown as the Union's technology needs have increased to meet demands related to virtual collaboration and teamwork, while also building MyNATCA, the replacement membership database.

"The members of this committee work around the clock to share their insight on a broad range of tools and systems that help NATCA members accomplish the work of the Union every day," ITC Chair Jason Doss said. "The energy and enthusiasm of the ITC members is exciting, and we're looking forward to rolling out more solutions that will continue to advance our Union's initiatives and representation."

As the ITC works to upgrade the Union's email processes, email lists, and a new grievance tracking system, committee members are working with the membership and committees to ensure the process is seamless. The ITC provides support, guidance, and recommendations to the National Executive Board, other committees, and NATCA members nationwide.

Train the Trainer Course & National Training Committee Meeting at National Office



NATCA Academy instructors and National Training Committee (NTC) members gathered at the National Office in Washington on April 19-20 for a meeting and a "Train the Trainer" course. The class was facilitated by National Training

Representative Jamaal Haltom (Las Vegas ATCT, LAS), and NTC member Aaron Katz (Phoenix TRACON, P50). New England RVP Mick Devine and Southern RVP Jim Marinitti also participated in the class to give new and existing instructors tools and techniques to create the most effective learning experience possible for NATCA members.

"Education is the fundamental building block of our organization," Devine said. "Educating our instructors to be able to provide knowledge to the next generation is what will keep this Union viable for generations to come."

The course was developed by The LABOR School at Penn State University and taught by Penn State instructors. The course helps NATCA Academy instructors and NTC members improve their skills as trainers and facilitators.

Attendees discussed adult learning styles, methods of developing and presenting training with impact, classroom management, and communication techniques that can improve learning retention and guarantee successful application beyond the classroom.

NATCA Participates in Meeting of The Global ATC Alliance

The Global Air Traffic Controllers Alliance, "The Alliance" for short, recently held a meeting in London. The Alliance is a coalition of labor unions representing aviation safety professionals from Australia, Canada, New Zealand, Spain, the United Kingdom, and the United States to speak with a collective voice on a range of subjects that have a common effect on the profession and the professionals they represent. President Rich Santa and former NATCA president and current Alliance Vice President Paul Rinaldi represented NATCA at this meeting.

Members of The Alliance met with Simon Hocquard, Director General of CANSO, to discuss a wide range of topics on how the two organizations can work together moving forward. CANSO — the Civil Air Navigation Services Organization — is a representative body of air navigation service providers (ANSPs) that together support more than 85 percent of the world's air traffic. One of the main focuses of this conversation was making sure the workforce has a voice and is included in discussions about future directions CANSO plans to take. During the meeting, participants also reviewed and rewrote parts of their constitution, planned for World ATM, updated their website, and discussed outreach efforts.

About The Alliance, Santa stated, "We continue to make sure that NATCA has a seat at every table where issues vital to our profession are being discussed. This meeting with The Alliance was important because it is giving labor a greater voice in CANSO initiatives. By growing partnerships and alliances with organizations that provide air traffic control services, with air traffic industry partners, and other stakeholders, we're ensuring NATCA members and the professions we represent are heard."


