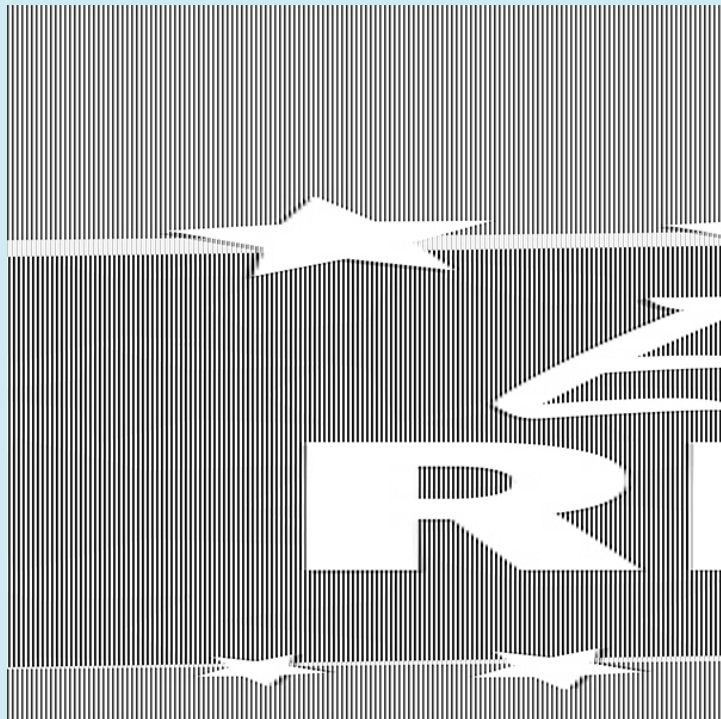




## 2022 National Representatives Election Results


and Annika Olson attended the Aero Club luncheon in Washington, D.C., where Department of Transportation Secretary Pete Buttigieg was the keynote speaker.
