## Public Service Loan Forgiveness (PSLF) program

Many NATCA members have attended Collegiate Training Initiative (CTI) schools and/or other college programs and have student loan debt. Do you have a federal student loan? If so, you may be able to benefit from temporary changes made to the Public Service Loan Forgiveness (PSLF) program. These changes, called the "Limited PSLF Waiver," are helping borrowers across the nation more easily get their loans forgiven. For a limited time, any person with federal student loans who has worked in government and/or for a private, non-profit organization for 10 years or more (even if not consecutively) may be eligible to take advantage of temporary, time-limited changes to the PSLF program made as a result of the COVID-19 national emergency to have all or part of their student debt canceled.

**You must take the steps necessary to qualify before October 31, 2022.**
