The event brought thousands of key players of manned and unmanned aviation together in Geneva, Switzerland, to collectively work on the global blueprint for future skies. The event was organized by the Civil Air Navigation Services Organization and builds on CANSO's history of global air traffic management events, including the award-winning World ATM Congress. Santa and LeBovidge met with representatives from leading companies to learn about the latest developments in ATM technologies. Understanding these technologies will be essential for our Union as the traffic controlled by NATCA member continues to become more complex.
