# President Santa Meets with Leaders of Congressional Aviation Committees That Oversee FAA Reauthorization

This week, NATCA President Rich Santa met with leaders of Senate and House aviation committees that oversee FAA reauthorization. An authorization bill is legislation used to authorize the activities of federal government agencies. For NATCA members, the FAA reauthorization bill is the authorizing measure that establishes, continues, and/or modifies FAA programs and activities. Congress passed a five-year authorization for the FAA in 2018, so the Agency's authorization must be renewed by Oct. 2023.
