Medical evaluations for air traffic controllers are essential to maintain their health, ensure their capability to handle the demands of the job, and ultimately contribute to the overall safety and efficiency of air travel, but medical requirements create unique employment and personal challenges for those in aviation safety careers. AMAS has been providing consultation regarding FAA medical certification issues to the nation's largest aviation unions since 1969.

CFS Panel Series: Pilots and Controllers

For the last presentation on the CFS 2023 main stage, a series of panels focused on pilot-controller communications and featured speakers from across the National Airspace System (NAS). NATCA's National Recurrent Training Lead Richard Kennington and NATCA Confidential Information Share Program member Dawn Johnson moderated the panels.

The discussion covered topics from safety considerations during go-arounds and missed approaches to the challenges posed by newer, more efficient aircraft in complying with multiple clearances, and included a roundtable

among military, general aviation, and business pilots, along with controllers, to address various issues, improve communication, and explore best practices.
