### Step 1: CFS Event Registration

## Step 2: National Excused Absence List

All NATCA members must read the registration guidelines to learn how to be put onto the national excused absence list for CFS. **All NATCA members must place their name on the excused absence request form on or before July 25, 2024.**

- There are no consequences for requesting an excused absence only to find out later you can't attend.
- Placing your name on the Excused Absence Request Form is NOT an automatic approval and release from your facility to attend. This is determined locally based on staffing and other circumstances.
