- Regional Reviews
 - NWP
 - Have a team selected, but haven’t trained them just yet
 - NCE
 - A lot of turn over this year, but caught up
 - 4 FCTs, with potentially more
 - Struggle the most with what to give these facilities
 - Poor staffing so don’t hear from them often
 - NEA
 - Looking for more people to join the team
 - Training one now
 - **Working on an official time document**
 - Will give to the group to review, may possibly be a leave behind
 - Working on a system to stay ahead of elections
 - NAL
 - Two changes this year, election cycles in the works
 - NNM
 - Have a small team finally, divided by districts
 - Working with Regional reps when new reps come onboard
 - NNE
 - Not much turnover
 - Have a rep that deals with the FCT onboarding (FAA that has prior FCT experience)
 - NSO
 - Not great at FCTs (have a rep that deals with them specifically)
 - Regional teams – getting together to refresh, in person or virtual

 - Face to Face Checklist
 - Changed “listserve” to “email list” throughout
 - Email list (Local & Regional)
 - Added to the social media (under communications)
 - Added IT support email
 - Added a MyNATCA section
 - Updated internet reimbursement steps
 - Updated Concur location
 - Added ATX
 - Added different reps under local/regional/national
 - **Sam will make the updated checklist “pretty” and send out to be reviewed on a virtual call**
- Organizing Conversation with John Bratcher
 - Election phase
 - Each company handles things differently here
 - New local is chartered
 - Things to be handled - constitution, election, IRS forms
 - National Office sets some things up
 - Organizing reaches out to RVPs (about 45 days after) with brand new local
 - Then mentorship phase starts
 - Checkpoints with RVP throughout
 - Mentorship phase
 - First 12 months – mentor into a functioning local
 - Lengthy checklist – an assortment of committee chairs
 - New list is being vetted by Organizing Committee and will be shared with Onboarding
 - Broken into chunks to lessen the overage of information
