

### NATCA's Western Pacific Region is Proud to Host the 20th Biennial Convention!

NATCA's Western Pacific Region (NWP) is proud to host the 20th Biennial Convention, taking place May 9–11, 2025, in San Francisco.



Here are a few facts about the region:

- NWP spans California, Nevada, Arizona, Hawaii, Guam, and American Samoa, covering more than 6,000 miles across the Pacific.
- Controllers here often work the first and last shifts in the National Airspace System due to the region's time zone reach.
- Southern California TRACON (SCT), located in NWP, is one of the busiest TRACON facilities in the world.
- NWP facilities regularly manage wildfires, earthquakes, and volcanic ash

with expert coordination and safety.

- Towers at Los Angeles (LAX), San Diego (SAN), San Francisco (SFO), and Honolulu (HNL) offer some of the most complex and scenic air traffic environments in the country.
- This region helped launch U.S. commercial aviation, with routes from Los Angeles and San Francisco to Asia and the Pacific as early as 1927.


### There is Still Time to Register and Secure Your Hotel Room for Convention
