RVP Lancaster proposes that NATCA will cover a third national Professional Standards Rep to fly to New Zealand to give the New Zealand ATC Union a class on Professional Standards. The cost is approximately \$5,000. This motion passed with EVP Devine and RVP Curtiss voting in opposition.

Untimely Voucher

EVP Devine proposes the approval of an untimely voucher for Caitlyn Valeri in the amount of \$745.80. This proposal was approved unanimously.

Corporate Partnership

RVP Bratcher proposed that Government Employees Health Association (GEHA) be named as a premium level corporate member of NATCA. This proposal was approved unanimously.

Federal Contract Tower Charters

RVP Bratcher proposed charters for the following locals: TOP, STC, MOT, GYR, ANE, RME, OJC, FDK, PMD, DET, CYN. This proposal was approved unanimously.

Personnel Issues

Proposals to address personnel issues presented were approved unanimously. This was conducted in Closed Session.

PR Firm / NATCA Advertising

President Daniels proposed a budget of \$934,511 to be used for advertising, which includes the remaining unpaid advertising cost of \$377,011.08 from our previous advertising fees which will not be carried forward after 2025. In addition, President Daniels proposes to give Public Affairs the ability to hire one of the four PR firms NATCA has interviewed for a budget of up to \$390,000. This proposal was approved unanimously.

RVP Merrick advises that Cassie Lichtenberg (SUX) and Sarah Winjum (DSM) will be named Iowa state co-coordinators.

NRX Alternate Legislative Rep

RVP Rausch proposes that Alex Hendrickson (OSF) be named the NRX Alternate Legislative Rep. This proposal was approved unanimously.
