A kind reminder that NATCA will be hosting an online training session on Articles 24, 32, and 34 for all Principal Facility Representatives and their negotiating teams covered by the Slate Book. The training will be conducted via Zoom and is scheduled by region for the dates and times listed below.

Alaskan, Northwest Mountain, and Western Pacific Regions

Tuesday, August 12; 12:30-2:30 p.m. PDT

Great Lakes, Central, and Southwest Regions

Wednesday, August 13; 2:30-4:30 p.m. CDT

New England, Eastern, and Southern Regions

Thursday, August 14; 3:30-5:30 p.m. EDT

**NOTE: We ask that you try to participate in the Zoom call for your region. However, if due to leave or other scheduling conflict you cannot, please join one of the other calls identified above.*

The training session will demonstrate and educate on the step-by-step process of building a Basic Watch Schedule (BWS) and Annual Leave agreements for your facility utilizing the provisions of the Slate Book. Specifically, the training will prepare for local negotiations by walking you through detailed examples. The goal of the training is to provide you with a practical understanding of Articles 24, 32, and 34 at the local level so you can efficiently and effectively collaborate/negotiate the agreements associated with these articles.

After registering, you will receive a confirmation email containing information about joining the webinar. If you cannot attend the webinar you registered for, you may go back and sign up for another date at any time prior to the training

session.
