Internal Grievance: The NEB unanimously voted to dismiss the internal grievance filed out of LGB.

ATSAP: The NEB unanimously approved Leanne Martin –AZO as a new member of the ATSAP team.

Annual Leave: The NEB unanimously approved 40 hours and 30 hours of leave to be paid out to Trish and Paul respectively rather than having them carry it over. Due to a very intensive work schedule this year, they were limited to just a few days off. We anticipated another very work intensive year in 2011 and leave will be limited again.

Impasse Process: The CSC is working on a process for mid-term bargaining that will expedite resolution at the facility and local levels. They will tie this process into Article 7 and Article 8 of the CBA.

IBB: The dry-run class that the RVPs and Dos will take on the new Interest Based Bargaining training will be in either ATL, DFW or KC on February 8-10. The course is three full days.

GATS: GATS will be taken down over the holidays for maintenance and updating. .

Internet Waiver: Waiting for a response from the FAA.

Ex-Officers' Meeting: Scheduled for January 13th in Atlanta.

RMT: Working with FAA to obtain a briefing.

Fatigue Briefing: Fatigue briefing for the Administrator has been rescheduled for January 20th.

Monthly FAA/FSS BU Telcon: Discussion between the Parties on pre-decisional involvement and collaboration on the automation replacement system, facility replacement at Dillingham and performance metrics.

OWCP Workgroup: The first OWCP collaboration meeting was yesterday. The Parties had preliminary discussion on a MOU on Time- Off following an OE.

FSS: The National alternate rep for FSS has resigned. Paul Rinaldi appointed, with NEB approval, Paul Klaben as his replacement. .

ES Strategic Workgroup: There is a planning next week in DC.

ERAM: NATCA is working with the Agency to improve the current process for prioritizing fixes contained in software updates.

GoTo Meeting renewal: The NEB approved the renewal of the corporate GoTo meeting account minus one of the national lines.

Functional Training: The Parties are working on a transition plan out of functional training at the ARTCCs impacted. ZAU may be keeping their hybrid program in place.
